NEW SERVICE WITH THE CITY OF SUSANVILLE WATER/NATURAL GAS DEPARTMENT

By signing this application, you are entering into an agreement that the City of Susanville provides your water and/or natural gas service and accept our rules and regulations.

In addition to completing the service application, the City of Susanville requires proof of property ownership or a completed, signed, valid copy of the rental or lease agreement for the property where service is being requested as well as a current driver's license or photo ID.

The City of Susanville can generally provide same day service if arrangements are made before noon or by the next business day if arrangements are made after noon. To insure service is connected when you need it, please make arrangements several days in advance.

Please take the time to provide all requested information to insure that your request can be expedited. Prior to receiving water and/or natural gas service the customer shall provide the City of Susanville with the following fees/deposits:

Deposits. Upon making application to the city for water/natural gas service, the consumer/applicant shall pay to the city a security deposit unless the applicant has met the deposit waiver requirements. Said deposit shall be retained by the city, to insure payment of all water/gas bills. When service to the applicant is discontinued permanently, this deposit, less any amount still due the city for water and/ or natural gas service, shall be refunded without interest.

(Municipal Code 13.08.040 G.)

Residential Customers: The deposit shall be \$200.00 for natural gas and \$75.00 for water service. Customers who have both water and natural gas service at the same address will have a maximum deposit of \$250.00.

After 12 months of good payment history for homeowners and 36 months of good payment history for renters, that may include more than one late payment, the deposit shall be credited to the customer's account.

Unsatisfactory payment history will result in an additional 12 month retention of the deposit by the City.

Deposits held by the City do no accrue interest.

Service Connection Fee. This service connection fee shall be applicable to all new service connections, or additions to existing service connections, whether commercial, individual, residential, multiple-dwelling unit (per unit), mobile home parks (per space) development, subdivision or otherwise, and must be paid to the city before the service connection or addition can be made.

(Municipal Code 13.08.040 E.2.)

Non-Pay Disconnect. If your service is disconnected for nonpayment you will be required to pay, not only the past due amount, but also the current balance due and a disconnect/non-pay fine of \$36.00 for either water or gas service or \$45.00 if you have both services. If deposits are not on the account at the time of disconnect they will also be required prior to reconnection.

Late Penalties - Except as otherwise provided by state law and unless otherwise provided in this code or by contract, when fees, bills, or charges for services (including but not limited to water and geothermal) are not paid by the thirtieth day after the billing date, interest at the rate of ten (10) percent per year shall be imposed and accrue on said debt and/or obligation until paid in full. Said interest accumulations shall be construed as being part of the original debt and/or obligation. (Prior code § 1.16)

*Late penalties owed will be added to your next billing cycle but are not required to be paid before reconnecting service.

Delinquent Payments and Penalties—A Lien Upon Real Property. Water/Natural Gas charges that have not been paid and any other delinquent rates, charges, and penalties, shall constitute a lien upon the real property served (except that no such lien should be created against any publicly owned property) and such lien shall continue until the delinquent rates, charges, liens and penalties thereon are fully paid or the property sold.

Tampering/Covering.

It is unlawful to tamper with a water or natural gas meter. In case of tampering, including but not limited to turning on or off of said meter, a fine of \$301.00 will be charged.

It is unlawful at any time to cover meter boxes with trash, rubbish, dirt, or other foreign matters, to permit vegetation or other shrubbery to grow over meter boxes, or to park automobiles or other vehicles over meter boxes.
